  - Phase 2 will be implementation of a role-based Contact form where contact reasons will change based on the role the user selects

#### Community Education Coordinators Update


- Completed Quarters 1 & 2
  - Will be receiving Quarter 2 reports July 31st.
  - 77 total workplan activities for the program year to be completed
- Quarter 1 Summary (February March)
  - CECs conducted trainings, attended events, and shared CTPL materials
    - Attended a total of 85 events with a total of 5000 attendees including:
      - 13 Workshops
      - 10 Trainings
      - 16 Community Events
      - 1 PTA Meeting
      - 45 Tabling at Businesses
  - Provided Direct Application Assistance to 48 people
    - For Quarters 3 & 4 we will be collecting information on the specific kinds of assistance people are receiving such as if they got help completing forms, navigating the Aflac portal, or answering questions about eligibility or coverage.

#### Community Education Coordinators Update

#### Quarterly Reporting Template

- CECs must provide updates on each of their specified work plan activities including any challenges they have encountered.
- Additionally, CECs provide data on the persons they provide direct application support to and the events that they host or attend.
- This information is collected in a reporting form provided to them which they update through an online share drive.
- At the end of each quarter, we summarize the reports and data in a summary excel file to track progress over the 4 quarters.
